1. Bern University of Applied Sciences and its degree programmes

What is Business Administration?

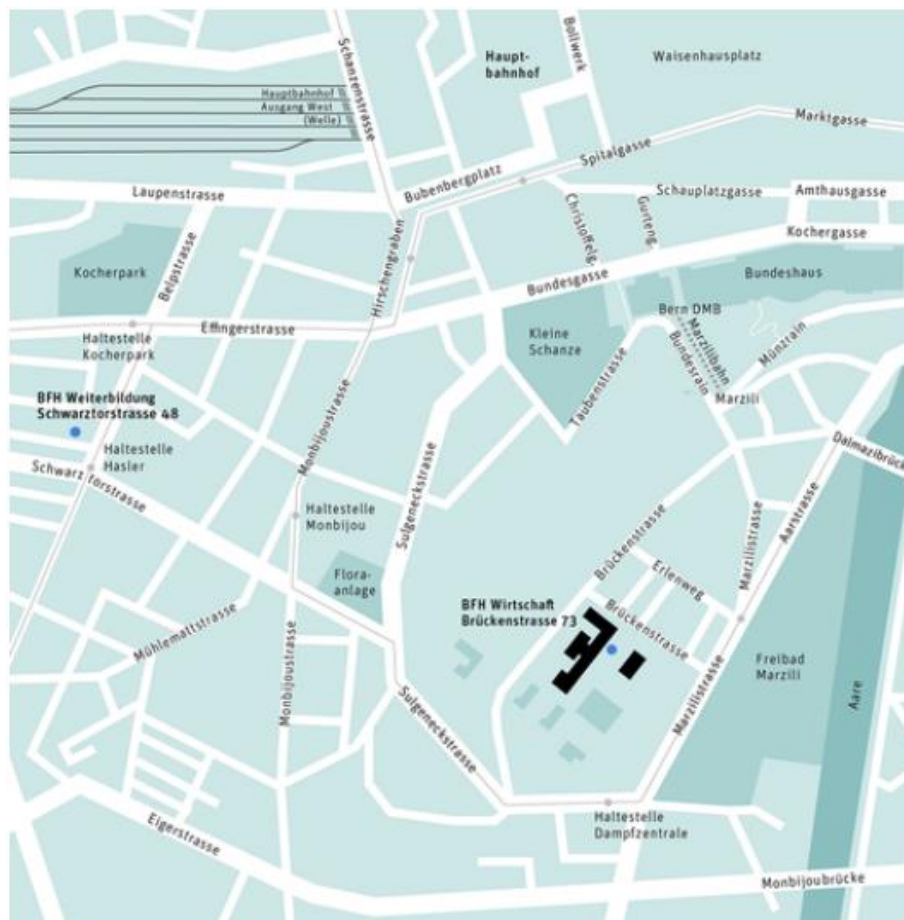
Business Administration is a challenging, interdisciplinary and wide-ranging field. The discipline focuses on business organisations and how they interact with their environment. This branch of economics assumes that goods and resources are always in short supply and must therefore be handled efficiently. It investigates, explains and answers economic issues from the point of view of business. Its practical orientation means that course graduates will be able to make contributions in various day-to-day situations in the companies they work for.

What is business information technology?

Business Information Technology is the science of designing, developing and using IT and communication systems to support business processes. Business Information Technology is a scientific discipline that combines Business Administration and IT.

2. Study organisation

Which study models are available?

Full-time - 3 years	<p>This model suits those who intend putting in maximum effort to reach their goal as soon as possible. Each year, you will be expected to devote approx. 1800 working hours to study, equivalent to holding down a full-time job.</p> <p>You will need to complete study modules so that you acquire an average of 60 ECTS credits each year.</p>
Work-study - 4 years	<p>If you wish to obtain a Bachelor's degree while you are in employment, this standard study model will be ideal for you. In this case, the modules that need to be passed as part of the full-time course are spread over eight semesters.</p> <p>If you take this type of model, you will need to complete modules and acquire an average of 42 ECTS credits per year, equivalent to 1260 hours work.</p> <p>To be recognised as employed applicants must work in a commercial or administrative position for at least 20 hours per week throughout the whole academic year. Business IT students must work in a commercial or IT field. You will be awarded three ECTS credits every second semester for the practical experience you are obtaining through your work. We recommend a maximum percentage of full-time employment of 50-60%</p>
Part-time - 4 years	<p>If you have other commitments alongside your degree programme, or are employed for less than a 50% FTE, then the part-time study model involving a minimum of eight semesters is the ideal solution.</p> <p>You will need to complete study modules so that you acquire an average of 45 ECTS credits each year. This is equivalent to a course workload of 1350 hours annually.</p> <p>In contrast to the work-study course, you will receive no ECTS credits for the extramural activities outside your Bachelor's degree programme.</p>

Can I change the study model during the degree programme?

In general, you always have the option of applying to change the study model for the coming semester. Whether it makes sense to change and when this should occur is decided through individual discussion with the student.

What are the class schedules?

Work-study and part-time courses:	<p><u>Semesters 1 - 4: semester.</u> Classroom hours are all day on Mondays and Tuesdays, and on Saturday until no later than 16.00 for both study models.</p> <p><u>Semesters 5 - 8: semester.</u> Classroom hours are scheduled for all day Thursdays and Fridays and on Saturday until no later than 16.00 for both study models.</p>	Classroom hours are generally all day on Mondays and Tuesdays and on Saturday until no later than 16.00.



Each classroom period lasts 45 minutes. Please reserve the corresponding time slots for each semester. Timetables change each semester and cannot be adapted to meet individual student requirements.

The required attendance times may differ from the standard models during the block and examination weeks (see [academic year schedule](#) on our home page).

Is there an attendance requirement for classes?

In the case of all modules, the relevant lecturers may make attendance compulsory and may take measures to verify attendance. However, lecturers may not require students to be in attendance at more than 85% of classroom lessons. Compliance with the attendance requirement is a prerequisite for admission to the proof of competence assessment procedure. Which modules are offered?

Timetables/curricula for [Business Administration](#) and [Business Information Technology](#) have been uploaded on our homepage. You will find the module descriptions below.

Can I also just attend individual modules?

Assuming sufficient places are available, persons who are not registered to study at BFH may also participate in courses. The fee is CHF 300 per module equivalent to 3 ECTS credits (usually equates to two hours per semester week).

How is my performance measured?

The degree programme follows the European Credit Transfer System (ECTS). One ECTS credit represents 30 hours of work. The average hours of work by a student for 60 ECTS credits in a full-time academic year is 1800 hours per year. The Bachelor's degree course has been successfully completed once 180 ECTS credits have been achieved (this is equivalent to 5400 hours work).

Can I complete a semester abroad?

You have the opportunity to study abroad for one or two semesters. The Bern University of Applied Sciences has partnerships with various universities / universities of applied science around the world. Informational events are arranged for the start of each semester. Here you can obtain all the necessary information relating to the semester abroad. Is it possible to receive a double degree?

The Bern University of Applied Sciences Business School (BFH) has established double degree agreements with different partner institutions ([Linnaeus University LNU](#) (Sweden), [Häme University of Applied Sciences HAMK](#), (Finland), [University of the Sunshine Coast USC](#), (Australia)). You have now the possibility to receive a degree from two different universities.

3. Admission and application

When is the deadline for course application?

The regular application deadline is 31 March each year. Application after this date is possible provided there are still places available on the course.

How much does the degree programme cost each semester?

Application/Matriculation (one-off)	CHF 100
Tuition fees (excl. teaching aids)	CHF 750
Contribution towards social and cultural facilities provided by BFH	CHF 24
Examination fee	CHF 80
Course material charge (lecture notes etc.)	CHF 95
Voluntary contribution to the students' association	CHF 15

In addition to the above, charges will also be levied for various study-related resources, such as photocopies, literature and internet access.

Am I able to apply for scholarships?

There are legal stipulations that provide for scholarships for those studying at Bern University of Applied Sciences. Students who have been registered as domiciled in the Canton of Bern for taxation purposes for at least two years may apply for the relevant scholarships and student loans offered by the Canton. Applications should be submitted to the education authority's grants office ("Abteilung Ausbildungsbeiträge der Erziehungsdirektion"). Which languages are required?

Most of the course modules are conducted in German. If your first language is not German, you will need to be competent in German at level C1 (e.g. hold a Goethe-Zertifikat C1). However, course literature may also be in English. Parts of the course are additionally taught in English. It may therefore be advisable for you to take an intensive course in English before commencing your course of studies.

Can I complete the degree programme in English?

The Bachelor's degree programme in Business Administration can be taken as a Bachelor of Science in Business Administration in the International Programme. Further information is available on our [homepage](#).

The Bachelor's degree in Business Information Technology is only offered in German.

Can I use ECTS credits I have already acquired?

If you hold equivalent qualifications that have been awarded by other institutes at the tertiary educational level, you will need to apply in writing to have these recognised for the purpose of admission to the course. The application will be reviewed prior to commencement of studies but not until you have been admitted to the degree programme.

Please specify in your application your request for recognition of acquired competences by 31 July of the year you start your studies.

Can I request who is placed in the class with me?

Class requests can be made to wirtschaft@bfh.ch up to the end of June. There is no guarantee that your request will be taken into account.

Are there any preparatory courses so that I can be fully prepared for the degree programme?

We offer preparatory courses for corporate accounting and financial accounting, the content of which is geared to the Bachelor's degree programme which follows. Further information regarding this and self-tests is available on our [homepage](#).
